### Site information

S.C. VOLTNET SOFTWARE S.R.L., as administrator of the healthandbeauty.ro website, reserves the right to make changes to these provisions without prior notification to users. Users will have permanent access to the terms and conditions of use of the site, by accessing the "Terms and Conditions" page at any time.

### Prices and taxes

### Delivery

The delivery of packages is made within a period of between one and seven working days, depending on the chosen delivery method, from the moment the package leaves the headquarters of S.C. VOLTNET SOFTWARE S.R.L. (not from the placement of the order).

The delivery of packages can be made through the Romanian Post or with courier companies. The customer can choose the desired delivery method when placing the order request on the site.

Conditions for returning products

Our wish is that the products we offer you are in full accordance with your needs. Otherwise, according to Ordinance no. 34/2014 on the legal regime of distance contracts, the products can be returned within 14 calendar days from receipt of the package: "Except for the case where the professional has offered to recover the products himself, the consumer returns the products or hands them over to the professional or to a person authorized by the professional to receive the products, without undue delay and within 14 days at the latest from the date on which he communicated to the professional his decision to withdraw from the contract in accordance with art. 11. The deadline is met if the products are sent back by the consumer before the expiry of the 14-day period". Unilateral termination of the contract within the 14-day period applies only to natural persons, legal persons not having this possibility.

The notification will be dated, signed and sent by you. by e-mail to: office@healthandbeauty.ro In the above-mentioned situation, our customers can return, within the period provided above, the purchased product, without showing any sign of damage or wear. In case the product shows signs of use and wear, according to Ordinance 34/2014 "The consumer is only responsible for the diminution of the value of the products resulting from their handling, other than what is necessary to determine the nature, characteristics and functioning of the products".

S.C. VOLTNET SOFTWARE S.R.L. undertakes to refund the customer the amounts received for the returned products, within 14 calendar days from receipt of the returned product, based on the return form or the notification sent by email to the above-mentioned address, completed by the customer. The data and bank account of the owner are completed in the return form / written notification. The return form on the site is only a model. According to the law, the customer may withdraw from the contract by an unequivocal statement, by any method he wishes: email, postal, verbally, etc.

Shipping costs, in the case of return, will be borne by the consumer according to Ordinance 34/2014: "The consumer bears only the direct costs related to the return of the products". The amount returned to the customer includes all amounts of money received by the seller from the customer for the respective product, including the initial transport costs, if applicable. All returned products for which the full amount is returned must be in perfect condition, without visible traces of use and with the original warranty certificate.

According to Law 249/2015, Art. 16, point 8, "it is prohibited to condition, in any form, the legal rights of consumers regarding the purchased product by keeping the packaging." According to the provision of OUG 34/2014 "the end user is only responsible for the diminution of the value of the products resulting from their handling, other than what is necessary to determine the nature, characteristics and functioning of the products. The diminution of the value of the products must not be discouraging for the end user to exercise his right of withdrawal." As a result, if the consumer returns the product in a condition that diminishes its value, the trader is allowed to deduct part of the amount returned to the customer.

Cosmetic products, make-up, UV gels, cannot be returned if they have broken seals or traces of use. These products sealed by the manufacturer to protect the contents (example: UV gels), cannot be returned unless they have the seal intact, or based on serious reasons (non-conforming product), requests based on possible opinions related to color shades will not be taken into account, the photos posted on the site are for informational purposes and cannot accurately reflect reality.

Please note! In cases where the returned products are damaged or incomplete, show signs of wear, scratches, bumps, electric shocks, missing accessories, missing warranty certificates, we reserve the right to withhold an amount from the product value (value with VAT), the amount that will be communicated after assessing the damages caused. The amount related to the return is reimbursed to a valid bank account (in lei) opened in the name of the invoice holder.

For orders containing products sent incorrectly by S.C. VOLTNET SOFTWARE S.R.L., the costs of returning and reshipping the products will be fully borne by S.C. VOLTNET SOFTWARE S.R.L.. The products will be returned to the seller via the Romanian Post or courier, without refund, after a telephone or email notification of the seller, using the contact details on the site, with the seller using the same method of reshipping the product. The buyer must ensure proper packaging of the returned product, so as not to suffer damage during transport.

For products that arrive damaged to the customer, the customer is obliged to notify the seller in writing of this within 48 hours of receiving the package, to the site's email address, presenting photo / video evidence of the product in question: photos of the product, packaging and any other information he may consider relevant in this regard. Terms and conditions for returning products

## Cosmetics

- with the original label;
- with all related accessories;
- without traces of use, without showing any sign of damage or wear;
- without damaged packaging, scratches
- to be sealed

### Devices

- with the original label;
- with all related accessories;
- with the original warranty certificate;
- without visible signs of damage;

• without unauthorized interventions or those that do not comply with the instructions for use that accompany the products;

• without damaged packaging, scratches, mechanical/electrical shocks.

• Products such as electric toothbrushes, oral irrigators, epilators, hair clippers or other personal care devices are exempt from the right of return, if they show signs of use or are unsealed, according to Article 16, letter E of O.U.G. 34/2014. Therefore, please do not open their packaging if you believe that the model is not suitable for you, for this category of products.

S.C. VOLTNET SOFTWARE S.R.L. undertakes to refund the customer the amounts received for the returned products, within 14 calendar days from the receipt of the returned product, based on the return form or the notification sent by email, completed by the customer. The return form must include the data and bank account of the holder. The return form on the site is only a model. According to the law, the customer may withdraw from the contract by an unequivocal statement, by any method he wishes: email, mail, verbally, etc.
