### **Moment of conclusion**

The contract between you and us is formed at the time you place the order on the website.

#### **Protection**

If an order cannot be accepted (e.g., out of stock, missing contact/delivery info) and you chose card payment, the paid amount will be refunded within 3 working days.

#### Our decision

We reserve the right to refuse, at our sole discretion and without explanation, to enter into a sales contract. We are not liable to you for refusing an order. Ownership of products is transferred to you only after full payment of all amounts, including shipping fees.

### PRODUCT AVAILABILITY

We cannot guarantee that the products listed at a given time will always be available. We are not liable if a product becomes unavailable. Although we strive to update stock status in real time, this may not always be accurate. All orders depend on stock availability.

#### Guarantees

If you ordered an unavailable product, we will inform you and offer similar alternatives of equal or close value. If you decline the suggested alternatives, we will cancel the order and refund your money within 3 working days.

## PRODUCT PRICES. PAYMENT. DELIVERY

Prices are displayed in RON and include VAT. If a pricing error is discovered, we will notify you promptly and either refund the extra amount you paid or request additional payment. If the corrected price is not acceptable or we cannot reach you, we will cancel the order and refund the amount within 3 working days.

Prices can be updated at any time. The applicable price is the one in effect at the time of the actual order.

## **Payment methods:**

- Cash on delivery
- Online card payment

If you choose online card payment, processing is done securely through Stripe Inc. We do not store your card data.

If the payment fails due to reasons beyond our control (e.g., insufficient funds, expired card), the contract is not concluded, and we are not obligated to deliver the products. You may try another payment method.

**Shipping fees** are not included in the product price, except for specific promotions stated on the site. For delivery terms, see our **Shipping Policy**.

No deliveries are made on Saturdays or Sundays. Delivery times may be extended during busy periods (e.g., holidays, Black Friday). Delays are due to third parties, and you agree not to hold us liable in such cases.
