

## Notice on the Protection of Personal Data (Legislative Decree 196/2003)

Dear User,

Pursuant to Article 13 of Italian Legislative Decree No. 196 of June 30, 2003 (Personal Data Protection Code), we wish to inform you that the personal data, including your email address, which you voluntarily send to marketplace@star.srl or via any other form on this website, will be collected, used, and processed by Star Srl in compliance with the aforementioned law.

In accordance with the articles of Legislative Decree No. 196/2003, the processing of personal data will be carried out in accordance with the principles of fairness, lawfulness, transparency, and respect for your privacy.

Star S.r.l. We would like to inform you about the following conditions:

The personal data we receive in the context of business relationships and/or for the development of advertising campaigns or for the establishment of contractual relationships will be processed:

a) For the purposes of tax compliance, accounting regulations, and general legal compliance.

Only for the purpose of exchanging commercial information and contact details, i.e., for managing pending pre-contractual negotiations in response to a potential request for use from Star Srl.

To fulfill obligations arising from agreed contracts, for the delivery of products, and for technical assistance and support regarding the products, including after the sale; for managing customer accounts, orders, shipments, invoicing, and monitoring creditworthiness.

b) For purposes related to commercial activities (marketing and advertising, information about future initiatives or new services offered).

The data may be shared with the tax authorities and with agencies or organizations that verify compliance with civil and tax law obligations after review and audits.

The data processing described in point a) above is necessary for fulfilling legal obligations and/or establishing or maintaining the contractual relationship.

Without the data processing described in point a) above, it is not possible to determine and fulfill these obligations and/or to continue the contractual relationship.

The provision in point b) is optional and serves to provide users with better service. Refusal to participate will have no consequences.

The user's personal data may be shared with other companies or external service providers specializing in the following for the purposes mentioned above:

- Software management, hardware, and information systems;
- Processing and recording activities;
- Activities such as printing, sending, packaging, transporting, and delivering items to users;

The processing operation is carried out manually using information and telematics tools. In fact, the data may be stored in paper archives and electronic files for a period not exceeding the duration and necessity of the processing, to allow for the identification and selection of aggregated data when needed.

The processing is carried out by the data controller's organization and its agents.

Processing is carried out strictly in accordance with the stated purposes and to ensure the security and confidentiality of the data itself by taking appropriate measures to avoid the risk of alteration, deletion, destruction, and unauthorized access or processing that is not permitted or incompatible with the purpose for which it was collected.

Should the user send sensitive personal data to a third party (purchasing prescription eyeglasses on behalf of a third party), they acknowledge that this transaction constitutes the processing of personal data, for which they, as the independent data controller, assume all obligations and responsibilities under the Data Protection Act. In this regard, they guarantee to Star S.r.l. that any third party designated by the user (and therefore treated by Star S.r.l. as having given informed consent to the processing of their personal and sensitive data) will be recorded and processed by the user in accordance with the provisions of the Data Protection Act and with the third party's explicit consent. To this end, the user grants Star S.r.l. the fullest possible indemnification from any disputes or claims for damages that may arise from this transaction. by relevant third parties due to the incorrect allocation of user-specific data in violation of regulations for the protection of personal and sensitive data.

Star S.r.l. informs users who agree to purchase that the processing of the contract requires the transfer of personal and potentially sensitive data to external parties of Star S.r.l., including employees of the company responsible for packaging and shipping (for users in EU member states), personnel of the transport company, and personnel of the relevant administrative and tax authorities based on national requirements for primary or secondary status and/or resulting administrative and tax measures (for users in non-EU countries).

By subscribing to the newsletter, the user consents to the processing of their personal data

and authorizes Star S.r.l. to process data for marketing purposes, for promotional material, and for profiling products purchased on the Allegro.pl website of Star S.r.l.

Star S.r.l. informs users that personal data may also include their image.

They inform you that the captured images will be stored in a third-party computer storage system, which is accordingly referred to as Star S.r.l.

Users of this website should be aware that data transmission over the internet cannot guarantee absolute security.

Therefore, users are responsible for verifying the accuracy of the personal data they transmit and, if necessary, correcting and updating it, and in any case, amending it during the period in which it is being processed. Star Srl is not obligated to perform any activity other than that necessary to ensure the proper and correct application of the security standards imposed by applicable regulations.

By contacting the data controller, you can obtain their name and the authorized entities with which Star Srl collaborates or cooperates.

Anyone who submits their personal data to us may exercise their rights under Article 7 of Legislative Decree 196/2003 at any time; the full text is given below.

Article 7 of Legislative Decree 196/2003

1. The data subject has the right to obtain confirmation as to whether or not personal data concerning him or her exist, even if not yet recorded, and to receive an intelligible statement of such data.

2. The data subject has the right to obtain information on:

a) the origin of the personal data;

b) the purposes and methods of processing;

c) the logic applied, where processing is carried out with the aid of electronic means;

d) the essential details of the data controller, the data processors, and the designated representative referred to in paragraph 5, point 2;

e) the subjects and categories of persons to whom personal data may be disclosed or who may become aware of such data because they are the designated representative of the State or the data processors.

3. The data subject has the right to:

a) the updating, rectification, or, where necessary, completion of the data.

b) The erasure, anonymization or blocking of data that has been unlawfully processed, including data that is not necessary for the purposes for which it was collected and subsequently processed;

c) A statement confirming that the processes described in a) and b) above have been communicated to the data subjects, including details of who has been notified or disseminated of the data, unless providing such information proves impossible.

4. The data subject has the right to object, in whole or in part:

a) on legitimate grounds, to the processing of personal data concerning him or her, even if relevant to the purpose for which it was collected;

b) to the processing of personal data concerning him or her for the purpose of commercial information, advertising, direct marketing, or other purposes related to market performance or interactive surveys for commercial communication.

In particular, anyone may at any time request that their personal data not be processed, in whole or in part, for advertising, promotional, direct sales, market research, or interactive commercial communication purposes by submitting their objection via email to Star Srl.

For any request pursuant to Article 7, subparagraphs 1 and 2, letters a), b), and c) of Legislative Decree 196/2003, Star Srl may, in cases where no data concerning them is available, request accurate information from the data subject, requiring payment of a small amount not exceeding the actual costs incurred by Star Srl, in accordance with the provisions and within the limits established in the regulation issued pursuant to Article 10, subparagraph 8 of Legislative Decree 196/2003.

By confirming the order, the user receives the aforementioned legal information and consents and authorizes the processing of their personal data in the manner and under the conditions specified in sections a) and b) of this legal information.

Star srl informs the user that the data controller may modify and update this privacy policy to implement and comply with any legal changes.

Pursuant to Article 25(c), Section IV, and Article 6, "Transfer of personal data to third countries," of Directive 95/46/EC, data may be transferred to non-EU countries or countries outside the European Economic Area that ensure an adequate level of protection for personal data. In any case, data processing will be carried out in accordance with the provisions of applicable rules and regulations.
